# **Purpose of the Study**

The purpose of this research project is to learn more about how housing and employment experiences during college affect international student's academic success and their long-term employment and immigration plans. The research will also look at the affect that Covid-19 had on international students at Sheridan.

Research of this type is important because it can help Sheridan create better programs and policies to support international students. The research may also be used to create better immigration policies for international students.

The project is being funded by the Sheridan Centre for Research through a SRCA Growth Grant.

## Risks and Benefits of Participation

You are being asked to participate in this study because you are an international student who was enrolled at Sheridan on or before February 1, 2020.

If you agree to voluntarily participate in this research, your participation will include the completion of a 45 minute survey.

There are some potential risks to you by participating in this research and they include the emotional impact of sharing your experiences and struggles as an international student. If you



experience these emotional impacts, there is a list of free mental health services at the end of this letter you can access.

There is a risk that if the data we collect was released, it could affect your immigration status. In order to protect against this, we will not ask you to share your name, and if you provide an email address it will be kept confidential to the extent provided by law. Your email address will be collected separately from your survey responses and only used to send you a stipend in appreciation for your participation. After the stipends have been sent and the survey closes, your email address will be deleted from our records. Your survey responses, with identifying information removed will be securely stored on a secure Sheridan College server. Survey responses will be retained for 15 years, after which they will be removed from Sheridan College servers and destroyed.

All data related to the survey findings will be presented only in summary form and your personal information will not be used in any report. Results and reports from this survey will be shared with the International Centre, who will have an opportunity to respond to the reports before they are published publicly. However, the International Centre will not have access to the survey responses directly.

If you do not feel comfortable answering any question in the survey, you may select the option "prefer not to say" or when you are asked to write your response, you can enter "prefer not to say." If you do not want to complete the survey once you begin, you can click "exit and clear survey." Data from incomplete surveys will be deleted.

Participation in the survey is completely voluntary and will not affect any of the services or support you received at Sheridan. If you are enrolled in a class with the investigators, it will not affect the outcome in that class. The data collected during the 2020 fall term, will not be analyzed until the spring term of 2021.

The potential benefits of your participation in this study include improvement to services at Sheridan as a result of the study's findings. To compensate you for any inconvenience related to your participation, you will be given \$25 CAD e-gift card. It is important for you to know that it is unethical to provide undue compensation or inducements to research participants.

# Follow-up Study

The investigators will be administering a follow-up study. Participation in the follow-up study is also voluntary and will not affect any of the services or supports you receive from Sheridan. The purpose of the follow-up study is to investigate if participants have met their long-term employment and immigration goals. If you participate in the follow-up study, you will be contacted 2 years after you graduate from Sheridan College, using an email you provide.

Your email will be kept confidential to the extent provided by law. If you choose to participate in the follow-up survey, your email address will be removed from the data and will be replaced with a number. A list linking the number with your email address will be kept in a password protected file on a secure Sheridan College server and will be kept separate from your survey responses ('data'). Your email address for the follow-up survey will be kept for 6 years. After 6 years, the file containing all email addresses will be removed from the server and destroyed. Sheridan College will protect the confidentiality of the data to the full extent of the law
